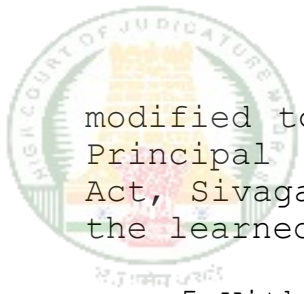

This Petition has been filed to relax the condition imposed in Crl.O.P(MD).No.367 of 2023, dated 11.01.2023.

2.The learned Counsel for the petitioner would submit that the petitioner has been complying with the conditions regularly and hence, he seeks for relaxation of the condition.

3.The learned Government Advocate (crl.side) appearing for the respondent would submit that the investigation has been completed and charge sheet has been filed and the case has been taken on the file of the Principal Special Court for Exclusive Trial of Cases under POCSO Act, Sivagangai.

4.Considering the said submission, the condition imposed by
