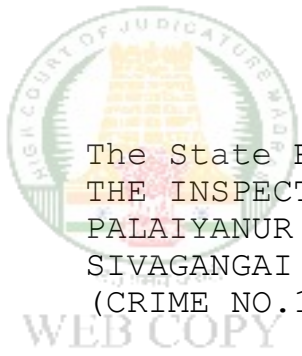

Order : This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of M/S.MUTHUVAI ILLAYARAJA.K, Advocate for the petitioner and of MR.M.VEERANTHIRAN, Government Advocate(Crl.Side) on behalf of the Respondent, the Court made the following order:-

This Petition has been filed to modify the condition in the order of this Court in Crl.O.P(MD).No.224 of 2023, dated 12.01.2023.

2.The learned counsel for the petitioners would submit that he is unable to furnish two sureties for each accused. Hence, prays to modify the condition.

3.Considering the reason stated by the petitioners, the condition in Crl.O.P(MD)No.224 of 2023, is hereby modified to the effect that the petitioners shall execute a bond for a sum of Rs.10,000/- with **one** surety each for a likesum. The other conditions in the said order shall remain intact.

4.Accordingly, this Criminal Miscellaneous Petition is ordered.
