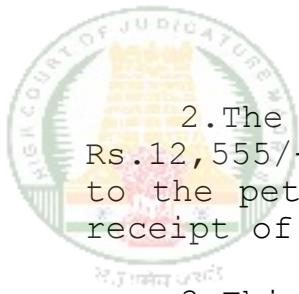

PRAYER IN WP (MD) No.4423 of 2023:-

To issue of Writ of Certiorarified Mandamus calling for the impugned order passed by 1st respondent in his proceedings Na.Ka.No. 795/A1/2017 dated 17.03.2020 and to quash the same and consequently directing the respondents to refund the amount of Rs. 36,705/- to the petitioner with interest at the rate of 18 percentage per annum till the date of realization within a time frame as may be fixed by this Honble High Court.
