Prayer in CRL MP(MD). 15844/ 2022 :

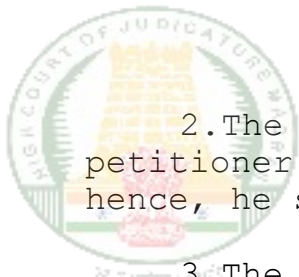
To relax the condition imposed upon the petitioner in Crl.O.P.9MD0.No.20894/2022 dt 25.11.2022.
