By an order dated 09.02.2021, this Court had granted interim stay on condition to deposit the entire award amount with accrued interest to the credit of Arbitration O.P.No.93/2015 before the Principal District Court, Madurai, on or before 09.03.2021. On 10.03.2021, this petition appears to have been filed.

2.We have noticed that in the earlier order instead of typing Arbitration O.P.No.93/2015, it is wrongly typed as MCOP No.93/2015. The same hereby stands modified. To comply with the condition, six weeks time is granted from today, failing which, the interim order already granted shall stand vacated automatically without further reference to this court. It is made clear that no further extension petition will be entertained at any cost.
