Prayer: Writ Petition filed under Article 226 of the Constitution of India to issue a writ of certiorarified mandamus calling for the entire records pertaining to the impugned tender cum auction notification published by the 3rd respondent vide his proceedings in Na.Ka.No.68/2020 dated 24.02.2020 and quash the same in respect of the Shop No.3 situated at Nithiravilai Sandahi, Ezhudesam Town Panchayat, Vilavancode Taluk,

Kanyakumari District and consequently direct the 3rd respondent to extend the existing leasehold right for the period from 01.04.2020 to 31.03.2023 in respect of the above said Shop No. 3 in favour of the petitioner.
