ORDER

This Criminal Original Petition has been filed, invoking Section 482 Cr.P.C., seeking orders, to direct the learned I Additional District Sessions Judge (Special Court for SC/ST Act Cases, PCR), Thanjavur, Thanjavur District, to consider and dispose of the bail application filed by the petitioner in Crime No.78 of 2023, dated 15.02.2023 on the file of the second respondent herein on the same day of his surrender before the said Court.

2. The petitioner is an accused for the offences punishable under Sections 147, 148, 294(b), 323, 324, 506(ii) IPC r/w Sections 3(l)(r), 3(l)(s) and 3(2)(va) of SC/ST (POA) Act, 1989 in Crime No.78 of 2023, pending on the file of the second respondent police and apprehending arrest, he has filed the present petition.

3. Heard the learned counsel appearing for the petitioner, the learned Government Advocate (Criminal Side) appearing for the State and perused the materials available on record.

4. In view of the specific bar under Section 18 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and also taking into consideration the possibility of misusing the pious intention of the Parliament against innocent persons, there shall be a direction to the learned I Additional District Sessions Judge (Special Court for SC/ST Act Cases, PCR), Thanjavur, Thanjavur District, to consider the petitioner's bail application, preferably on the same day of his surrender in connection with Crime No.78 of 2023 on the file of the second respondent police and pass appropriate orders, in accordance with law, after affording due opportunity to the victim under Section 15(a) of the SC/ST Act. The petitioner shall surrender before the concerned jurisdictional Court, within a period of fifteen days, from the date of the receipt of a copy of this order.
