ORDER

The writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus directing the respondent to grant permission and protection for cultural event namely Adalpadal & Themmanku Innisai scheduled to be held on 07.03.2023 and 08.03.2023 at night in connection with Masi Magam Festival in Arulmigu Sri Poorana Puskala Sametha Ayyanar Temple at Sanakarai Village, Peravoorani Taluk, Thanjavur District by considering the petitioner's representation dated 17.02.2023.

2. Mr.E.Antony Sahaya Prabahar, learned Additional Public Prosecutor takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3. The learned counsel appearing for the writ petitioner submitted that Masi Magam Festival for the temple, by name, “Arulmigu Sri Poorana Puskala Sametha Ayyanar Temple” situated at Sanakarai Village, Peravoorani Taluk, Thanjavur District, is going to be held on 07.03.2023 and 08.03.2023. Subsequent to the same, in order to conduct the

Adalpadal on 07.03.2023 and Themmanku Innisai on 08.03.2023, they sought permission of the police by giving a representation dated 01.02.2023. But, the second respondent has not considered the said representation. Since no order was passed, the writ petitioner has come before this Court for the above said relief.

4. The learned Additional Public Prosecutor appearing for the respondents would submit that the second respondent has received the representation of the writ petitioner and the same is pending for consideration. He would further submit that they may be permitted to conduct the Adal padal on 07.03.2023 from 07.00 p.m. to 10.00 p.m. and Themmanku Innisai on 08.03.2023 from 07.00 p.m. to 10.00 p.m.

5. At this juncture, the learned counsel appearing for the writ petitioner would submit that they are ready to conduct the programme as stated by the learned Additional Public Prosecutor.

6. I have considered the submission of the learned counsel appearing for the writ petitioner and the learned Additional Public Prosecutor appearing for the respondents.

7. It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai had issued a circular memorandum in Rc.007301/Genl.I (1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the writ petitioner is directed to file an undertaking affidavit incorporating the date and time of the cultural programmes before the second respondent and on such filing, the second respondent is hereby directed to consider the representation of the writ petitioner, dated 01.02.2023 and pass suitable orders based on the above said circular.

8. With the above direction, this writ petition stands disposed of.
