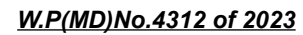

ORDER

The writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus directing the respondents to grant permission and protection for cultural event namely Adal Padal scheduled to be held on 22.03.2023 at about 07.00 p.m. to 12.00 p.m. in connection with 13th Masi-Panguni Thiruvizha in the month of Panguni in Arulmighu Sri Muthumariamman Temple at Chellanchetty Village, Karaikudi Taluk, Sivagangai District by considering the petitioner's representation dated 18.02.2023.

2. Mr.E.Antony Sahaya Prabahar, learned Additional Public Prosecutor takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3. The learned counsel appearing for the writ petitioner submitted that 13th Masi-Panguni Thiruvizha for the temple, by name, “Arulmighu Sri Muthumariamman Temple” situated at Chellanchetty Village, Karaikudi Taluk, Sivagangai District, is going to be held on 22.03.2023. Subsequent to the same, in order to conduct a cultural programme on

7. It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai had issued a circular memorandum in

Re.007301/Genl.I (1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the writ petitioner is directed to file an undertaking affidavit incorporating the date and time of the cultural programme before the second respondent and on such filing, the second respondent is hereby directed to consider the representation of the writ petitioner, dated 18.02.2023 and pass suitable orders based on the above said circular.

8. With the above direction, this writ petition stands disposed of.
