ORDER

3. The case of the petitioner is that he is working as Special Grade Tradesman in the respondent Corporation. The petitioner's daughter marriage function is going to be conducted on 24.03.2023. Hence, the petitioner has made an application to the respondents on 17.02.2023, seeking loan amount of Rs.8,00,000/-. Since the said application has not been considered, the present writ petition has been filed.
