COMMON ORDER

The present revision petitions have been filed by the plaintiff in a suit for declaration of title and permanent injunction seeking for an expeditious disposal of I.A.Nos.4, 5 and 6 of 2021.

2. I.A.No.4 of 2021 has been filed to implead additional defendants namely defendants 4 to 6, I.A.No.5 of 2021 has been filed seeking interim injunction as against the proposed parties from disturbing the possession of the plaintiff and I.A.No.6 of 2021 has been filed to implead additional defendants 7 and 8.

3. According to the learned counsel appearing for the plaintiff, these applications were filed in April-2021 and after enquiry, they were posted for orders in April-2022, but so far no orders have been passed.

4. Considering the aforesaid facts, the learned Subordinate Judge, Kuzhithurai, is directed to dispose of I.A.Nos.4, 5 and 6 of 2021 on merits and in accordance with law, after giving due opportunity to the parties, on or before **30.04.2023**.

5. With the above observation, these Civil Revision Petitions stand allowed. No costs.
