This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant M/s.K.R.Shivashankari and the counsel for the respondents Mr.M.Karthick are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

The Tribunal has awarded a sum of Rs.23,05,020/- (Rupees Twenty Three Lakh Five Thousand Twenty only). Aggrieved against the same, the Insurance Company has filed this Appeal.

After negotiation between the parties, this matter is settled for a sum of Rs.19,90,000/- (Rupees Nineteen Lakh Ninety Thousand only), along with 7.5% interest. The appellant/insurance company has already deposited a sum of Rs.15,00,000/- (Rupees Fifteen Lakh only) as per the interim order of this Court dated 05.06.2023. The balance amount shall be paid within a period of two (2) weeks from the date of receipt of a copy of this order. The claimants are permitted to withdraw the same.
