PRAYER: Petition filed under Article 226 of the Constitution of India to issue a writ of Habeas Corpus, calling for the entire records connected with the detention order passed in H.S.(M) Confdl.No.22/2023 dated 10.02.2023

on the file of the second respondent herein and quash the same and direct the respondents to produce the detenu or body of the detenu namely Marikannan @ Pandukannan @ Kannan, aged about 24 years, S/o.Marimuthu, now detained at the Central Prison, Palayamkottai, before this Court and set him at liberty forthwith.

ORDER

(Order of the Court was made by M.S.RAMESH,J.)

The petitioner is the detenu viz., Marikannan @ Pandukannan @ Kannan, aged about 24 years, S/o.Marimuthu. The detenu has been detained by the second respondent by his order in H.S.(M) Confdl.No.22/2023 dated 10.02.2023 holding him to be a "Goonda", as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.

2. We have heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondents. We have also perused the records produced by the Detaining Authority.

3. Though the learned counsel for the petitioner has raised several other grounds to assail the order of detention, he has mainly focused his argument on the ground that the copy of the initial remand order has not been furnished to the detenu, despite the same has been sought for by the petitioner in his representation. Therefore, on the sole ground, the detention order is liable to be quashed.

4. The learned Additional Public Prosecutor has not filed his counter. However, he strongly opposed the Habeas Corpus Petition. It is further submitted that investigation has been completed in this case and final report has been filed in S.C.No.279 of 2023 and the same is pending before the I Additional District Court, Thoothukudi.

5. On consideration of the submissions made on either side and upon perusal of the documents available on record, especially, the representation made by the petitioner dated 27.02.2023, he had sought for the initial remand order, however, the same has not been furnished to the detenu, which vitiates the order of detention.

6. In the result, the Habeas Corpus Petition is allowed and the order of detention in H.S.(M) Confdl.No.22/2023 dated 10.02.2023 passed by the second respondent is set aside. The detenu, viz., Marikannan @ Pandukannan @ Kannan, S/o.Marimuthu, aged about 24 years, is directed to be released forthwith unless his detention is required in connection with any other case.
