It is stated that based on the outcome of enquiry, further action will be taken.

4. The first respondent is directed to put the fourth respondent on notice and conclude enquiry and dispose of the petitioner's representation dated 01.03.2022. This shall be done by the first respondent within a period of four months from the date of receipt of a copy of this order.
