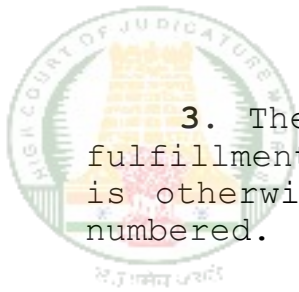
PRAYER IN SA(MD)SR.No.61985/2019 :
