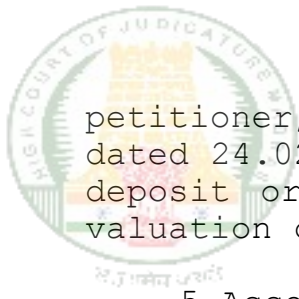
Order : This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of M/S.JEGANATHAN C, Advocate for the petitioner and of MR.B.THANGA ARAVINDH, Government Advocate (Crl.Side) on behalf of the Respondent, the court made the following order:-

This Criminal Miscellaneous Petition has been filed to modify the condition to deposit original title deeds of the immovable property modified as the value to be determined at market value.

2.Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Crl.Side) appearing for the respondent.

3.This Court by an order dated 24.02.2023 had directed to petitioner to deposit the original title deed of immovable property worth about Rs.15,00,000/-, since he is unable to deposit the same, he is still in custody hence he seeks modification of the said condition.

4.Taking into consideration the facts and circumstances of the case and also the submission made by the learned counsel for the



petitioner, the condition imposed in paragraph No.8 of order dated 24.02.2023 is modified to the effect that the petitioner shall deposit original title deed worth about Rs.15,00,000/- along with valuation certificate issued by the authorities concerned.

5. Accordingly, the Criminal Miscellaneous Petition is allowed.
