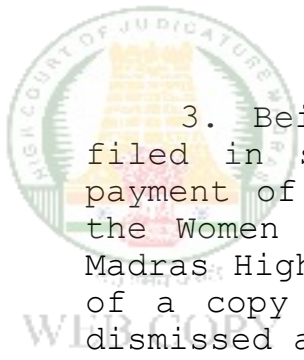
PRAYER IN CRL RC(MD)SR.No. 28545 of 2022:
