ORDER

The learned counsel for the petitioner submitted that after completing the investigation, the respondent police filed the final report before the concerned Court and the same was taken on file in C.C.No. 385 of 2021. Thereafter, no progress has been made in the trial process. Hence, this petition has been filed.

3. A perusal of CD file shows that a specific direction was issued by this Court in Crl.O.P(MD).No.18849 of 2021 dated 01.12.2021 to the respondent to serve the summon to the accused. So far, the summon was not served to the accused persons. They did not surrender before the concerned Court also.
