ORDER

During the course of the arguments, the learned Counsel for the petitioner stated that further brothers and sisters, namely, Sengol, son of Sevanthi Nadar, Amalorpavam, wife of Kulanthaisamy Nadar, Innasi Ammal wife of Alangaram, and Arulandu s/o. Sevanthi Nadar are also necessary parties for adjudicating the issue raised in this Writ Petition.
