2. Mr.E.Antony Sahaya Prabahar, learned Additional Public Prosecutor takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

They may be directed to give fresh representation mentioning alternate date and venue of the public meeting and on such representation, the third respondent may be directed to consider the same.

Recording the submission made by the learned Additional Public Prosecutor, since the meeting is scheduled to conduct the meeting on 05.03.2023, the writ petitioner is at liberty to make fresh representation by fixing date, time and venue within a week from the date of receipt of copy of this order, the third respondent is directed to consider the same and pass orders within a period of three days from the date of representation.
