“This Court vide order dated 18.07.2023 directed the learned Judicial Magistrate No.II, Madurai to complete the trial in C.C.No.442 of 2008, within a period of two months from the date of receipt of a copy of that order.

2.The learned Judicial Magistrate No.II, Madurai vide a letter dated 26.12.2023 bearing D.No.3924 has stated that the case was posted on 16.11.2023 for framing of charges and on that day it was informed that A6 died. Therefore, the case was posted on 21.11.2023. On that day, both side counsel reported that mediation talk is going between the parties. Thereafter, on 07.12.2023 charges were framed and on 12.12.2023, when the case is posted for complainant side evidence, A7 reported died. Now, the case is posted for cross-examination of P.W.1.
