**Prayer in CRL A(MD) . 206/ 2022 :**

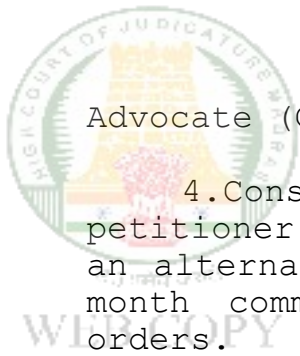
