ORDER

The Writ Petition has been filed in the nature of a Mandamus seeking a direction to the respondents to dispose an application dated 07.06.2022 and issue patta for house property measuring 718 square feet in T.S.No.1628/2A, New T.S.No.174, Ward No.6, Thirumalaisampuram, Dindigul Town, Dindigul East Taluk, Dindigul District.

2. It is stated in the affidavit filed in support of the Writ Petition, it had been stated that the petitioner had been in possession for a considerable period of years. But patta had not been granted. Seeking patta a representation had been given.
