3.Considering the facts and circumstances of the case, the condition already imposed on the petitioner is fully relaxed.

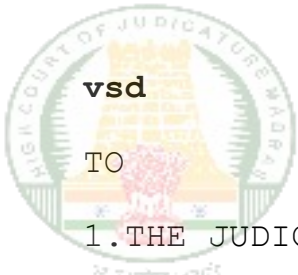
4.Accordingly, the Criminal Miscellaneous Petition is allowed.
