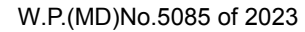

ORDER

The petitioners have filed the present Writ Petition in the nature of Certiorarified Mandamus relating to an auction notification, dated 01.02.2022 issued by the respondent herein with respect to 13 shops.
