2. When the matter is taken up for hearing, the learned Additional Public Prosecutor appearing for the respondent police submitted that a case in crime No.13 of 2023 was registered against the petitioner. On that purpose only, enquiry was made to the petitioner.

3. In the representation dated 18.02.2023, bald allegation has been made against the respondent police as if they foisted false case upon the

petitioner frequently and even registering the case under NDPS Act.
