2. Subject to filing of such memo, Registry is directed to number the civil revision petition and post the case for admission.

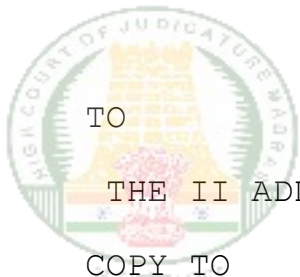
