Pleased to set aside the Judgment and Decree dated 14.12.2007 in A.S.No. 80/2005 on the file of the Subordinate Judge, Trichirappalli, confirming the Judgment and Decree dated 05.04.2005 in O.S.No. 292/1997 on the file of the District Munsif Court, Trichirappalli and allow the second appeal.
