2.The learned Government Advocate (Crl.Side) appearing for the respondents has made a submission that the order passed by the Human Rights Commission in SHRC.No.2667 of 2016, dated 17.06.2022 had been implemented and the compensation awarded had already been settled in favour of the victims. That apart, departmental disciplinary proceedings are initiated against the erred officials and the same is pending. More so, criminal case is under process.
