3.Considering the facts and circumstances of the case, the condition in Para No.9 imposed by the trial Court in Crl.M.P.(MD) No.6389 of 2022, dated 17.11.2022 is modified to the effect that **"In the result, the petitioner in Cr.M.P.No.6389 of 2022 is ordered to be enlarged on bail on his executing a bond for Rs.10,000/- each, instead of Rs.25,000/-, along with two sureties each for a like sum each to the satisfaction of Judicial Magistrate, Tirumangalam subject to conditions."** All other conditions in the said order dated 17.11.2022 shall remain unaltered.
