This Criminal Original Petition has been filed to direct the second respondent not to harass the petitioner under the guise of enquiry based on the petitioner's representation dated 10.03.2023.

2. The learned counsel for the petitioner would submit that the entire amount that was collected by the petitioner, was later transferred and handed over to one Rahmankhan, against him also the petitioner gave a complaint. In spite of handing over all the documents which are available with the petitioner pertaining to the above said transaction in the form of banking, that was not taken care of by the third respondent herein. But they are insisting upon the petitioner to settle the issue.

3. However, the learned Additional Public Prosecutor would submit that based on the complaint given by this petitioner and as well as one Manthirammoorthy, both were enquired in CSR No.292 of 2022 and 669 of 2022 and closed on the basis of understanding that was reached between the parties.
