The learned Counsels appearing for the respondents have submitted that there is no stay in the present case and pending writ petition the respondents have granted the license to the Self-Help Group. The petitioner has challenged the same in W.P.(MD)No.12534 of 2023. In the meanwhile, the license period of the petitioner was over and the respondents have not extended the license to the petitioner. Therefore, nothing survives for adjudication.
