PRAYER :-

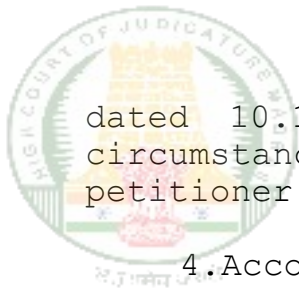
For Bail in Crime No.601/2022 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner/A5 who was arrested and remanded to judicial custody on 04.09.2022 for the offence punishable under Sections 8(c) r/w 20(b)(ii)(C), 25 and 29(1) of NDPS Act 1985 in Crime No.601 of 2022 on the file of the respondent police, seeks bail.

2.The case of the prosecution is that the accused persons were found in illegal possession of 23kgs of Ganja. Hence, the case.

3.Though the petitioner stated that no recovery was made from her, he also travelled in the lorry along with A1 and other accused persons, were found in possession of 23kgs of Ganja. The petitioner was in possession of 4kgs of Ganja. All the accused were in constructive and conscious possession of 23kgs of Ganja. That apart, this Court had already dismissed the bail applications in respect of

dated 10.11.2022 and 04.01.2023. Since there is no change in circumstances, this Court is not inclined to grant bail to the petitioner.

4. Accordingly, this Criminal Original Petition is dismissed.
