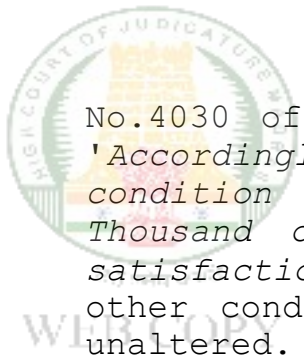

Order : This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of M/S.KARUNANITHI M, Advocate for the petitioner and of M/S.B.THANGA ARAVINDH, Government Advocate (Crl.Side) on behalf of the Respondents, the court made the following order:-

This Criminal Miscellaneous Petition has been filed to modify the condition imposed in Crl.O.P.(MD)No.4030 of 2023 dated 07.03.2023 directing the petitioner to execute with one surety blood related sureties each a like sum to the satisfaction of the learned Judicial Magistrate No.IV, Madurai instead of petitioner to execute with two surety blood related sureties each a like sum to the satisfaction of the learned Judicial Magistrate No.IV, Madurai.

2.Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Crl. side) appearing for the respondent.

3.Considering the facts and circumstances of the case, the condition imposed in Para No.6(a) imposed by this Court in Crl.O.P.(MD)



No.4030 of 2023, dated 07.03.2023 is modified to the effect at
'Accordingly, the petitioner is ordered to be released on bail on condition to execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.IV, Madurai." All other conditions in the said order dated 07.03.2023 shall remain unaltered.

4. Accordingly, the Criminal Miscellaneous Petition is allowed.
