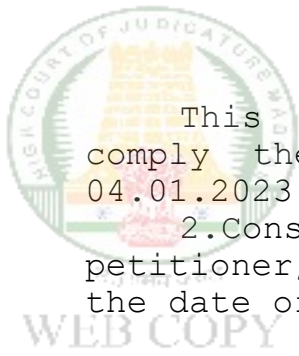
Prayer in CRL MP(MD) . No.4648 of 2023
