2. Mr.B.Nambiselvan, learned Additional Public Prosecutor takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

The learned Additional Public Prosecutor appearing for the respondent police submitted that because of some rivalry between the two groups, FIRs in Crime Nos.27 and 28 of 2022 have been registered against two community people. On that ground, he vehemently opposed to grant permission to conduct the programme.
