ORDER

This Criminal Original Petition has been filed to quash the impugned FIR in Crime No.10 of 2019, dated 21.07.2019 registered on the file of the first respondent police under Sections 120(b) and 420 IPC, as against the petitioner herein.

2.Today, when the matter is taken up for hearing, the learned Additional Public Prosecutor appearing for the first respondent would contend that the first respondent police, after elaborate investigation and examination of witnesses, filed charge sheet as per prima facie materials available as against the accused and thereby, this petition is liable to be dismissed.

3.The learned counsel appearing for the petitioner seeks liberty to challenge the charge sheet in separate proceedings. He would further contend that the copy of the charge sheet may be served to him.
