Prayer in CMP(MD). 3117/ 2019 :

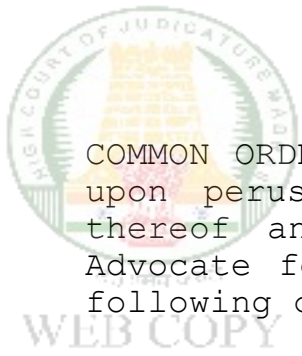
