The Writ Petition has been filed in the nature of a Mandamus seeking a direction to the respondents, particularly, the third

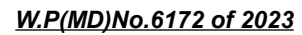

2. When the matter came up for admission, this Court had directed the petitioner to apply for patta through online. The learned counsel had now produced a document which reflected that the petitioner had applied for patta through online in application No. 2023/0103/28/392008 dated 23.03.2023.

3. The learned Special Government Pleader drew notice of this Court to an Advocate notice issued on behalf of the petitioner herein to the respondents herein wherein, it had been stated that the second respondent / Tahsildar (Forest), Thoothukudi, Thoothukudi District, had encroached into the lands of the petitioner to an extent of 1/2 cent of land and had put up a construction.



5. With the above directions, the Writ Petition stands disposed of. No costs.
