I state that under these circumstances I have filed this transfer petition to withdraw and transfer H.M.O.P.No:78 of 2022 on the file of the learned Sub Judge, Ambattur to the file of the learned Sub Court, Dindigul district."*

4. Being satisfied with the reasons given, this Court is inclined to allow this Transfer Civil Miscellaneous Petition. Accordingly, there shall be a direction for transfer of H.M.O.P.No.78 of 2022, pending on the file of the Sub Court, Ambattur, to the file of the Sub Court, Dindigul. The learned Sub Judge, Dindigul, shall endeavour to dispose of H.M.O.P.No.78 of 2022, on it being re-numbered, as expeditiously as possible, preferably, within a period of 12 months from the date of receipt of a copy of this order.

5. This Transfer Civil Miscellaneous Petition stands allowed with the above direction. No costs. Consequently, connected Miscellaneous Petition is closed.
