2.The learned Additional Public Prosecutor appearing for the respondent police would submit that based upon the complaint given by the third respondent, enquiry in C.No.99 of 2023 was undertaken. During the course of the enquiry, the petitioner as well as the third respondent appeared before the enquiry officer and at the conclusion of the enquiry, the petitioner has given undertaken that he is ready to execute the sale deed in favour of the third respondent, after receiving the entire balance amount. On the basis of the above said undertaking, the complaint was closed.
