2.The contention of the petitioner is that based on the complaint lodged by the 2nd respondent, the 1st respondent registered the First Information Report in Crime No.60 of 2021 for the offences punishable under Sections 294(b) and 323 of IPC, against the petitioner.

3.The further contention of the petitioner is that they compromised the issue with the 2nd respondent amicably.

4.The petitioner and the 2nd respondent appeared before this Court along with their counsels and also produced their Aadhar cards. They were also identified by the learned Government Advocate (Criminal Side) and the Investigation Officer. Both the parties were enquired by me and they accepted that the issue was settled between them.

5.Considering the totality of the circumstances, the nature of the allegations levelled against the petitioner and also in view of the compromise arrived at between the parties, this Court is of the opinion that no useful purpose will be served by keeping the matter pending and inclined to quash all further proceedings in Crime No.60 of 2021 pending on the file of the 1st

respondent police in respect of this petitioner. Further, the offence is also compoundable one.

6.In the result, the Criminal Original Petition stands allowed and the entire proceedings in Crime No.60 of 2021, pending on the file of the 1st respondent police is hereby quashed in respect of the petitioner.
