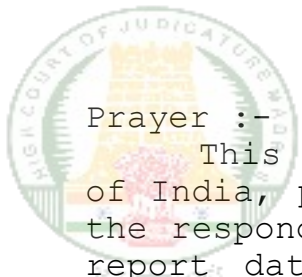

This Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents No.1 to 5 to implement the Survey boundary fixation report dated 24.06.2013 filed by the 3rd respondent to the 2nd respondent and to restore the patta land bearing survey No.545/1, Patta No.2215 extent 7.57.0 hectares, 18.70 acres, situated at Chettipatti Village, Kulathur Taluk, Pudukkottai District to the petitioner on the basis of the petitioner representation dated 20.02.2015, 23.02.2016, 14.12.2017, 21.08.2019, 29.07.2021 within stipulated time.
