Let the second respondent herein enquire the above said representation by summoning the private respondents and petitioner, find out the situation as to whether any life threat is made to the petitioner. On the basis of the above said enquiry, further action may be taken either by the petitioner or by the concerned authorities. For that purpose all the parties must appear before the second respondent. Let the above said
