After extensive arguments on either side, the learned counsel for the petitioners would submit that the petitioners would be satisfied, if the representation dated 05.03.2021 submitted by them is considered by the respondents and they may be provided with alternate places for street vending.

2. In the light of the above, the Writ Petition is allowed directing the second respondent to consider the representation of the petitioners, dated 05.03.2021, in case, the Town Vending Committee has not been constituted. In the event of the Town Vending Committee being constituted, the representation of the petitioners dated 05.03.2021 shall be forwarded to the Town Vending Committee and the Authority of the Town Vending Committee shall dispose of
