ORDER

This writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus directing the respondents, directing the respondents to grant permission and necessary protection to conduct the Adal Padal Programme on 07.04.2023 at 07.00 p.m to 10.00 p.m in connection with “Thiru Vizha” of Arulmigu Sri Pattatharasi Amman Thirukovil at Kannamangalapatti, Singampunari Taluk, Sivagangai District.

2. Mr.P.Kottai Chamy, learned Government Advocate (Crl. Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3. The learned counsel appearing for the writ petitioner submitted that festival for the temple, by name, “Arulmigu Sri Pattatharasi Amman Thirukovil” at Kannamangalapatti, Singampunari Taluk, Sivagangai District, is going to be held on 07.04.2023. Subsequent to the same, in order to conduct a cultural programme on 07.04.2023 at about 07.00 p.m., to 10.00 p.m, they sought permission of the police by giving a

representation dated 23.03.2023. But, the second respondent has not considered the said representation. Since no order was passed, the writ petitioner has come before this Court for the above said relief.

4. The learned Government Advocate(Crl. Side) appearing for the respondents would submit that the second respondent has received the representation of the writ petitioner and the same is pending for consideration. He further submitted that in the neighboring village, twenty days prior to the date of presentation of the representation, murdered was took place in the similar event, over which, the apprehension of breach of peace, by the respondents.

5. I have considered the submission of the learned counsel appearing for the writ petitioner and the learned Government Advocate (Crl. Side) appearing for the respondents.

6. It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai had issued a circular memorandum in Rc. 007301/Genl.I (1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the second respondent is hereby directed to consider the representation of the writ petitioner, dated 23.03.2023 and taking into account the location of murder also considering the submission of the learned Government Advocate(Crl. Side), pass suitable order. Depending upon the outcome of the representation dated 23.03.2023, the petitioner shall workout his remedy through appropriate proceedings.

7. With the above direction, this Writ Petition stands disposed of.
