This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant/s Ms.K.R.Shivashankari and the counsel for the first respondent Mr.G.Prabhu Rajadurai are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

Already the Tribunal has passed an award of Rs.11,05,000/- with 7.5% interest. After due deliberation, both the parties have agreed for settlement of Rs.11,65,000/- as full quit. Already a sum of Rs.1,05,000/- was awarded to the third respondent herein before the Tribunal and she is permitted to



withdraw the same. The remaining amount of Rs.10,60,000/- shall be withdrawn by the first .
The excess amount, if any, shall be refunded to the Insurance company.
