Prayer in CRL MP(MD).5287/2023 :

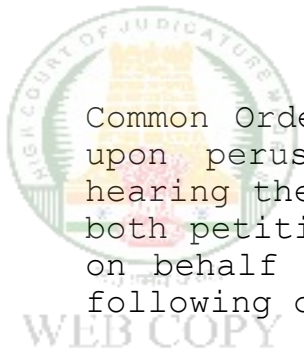
