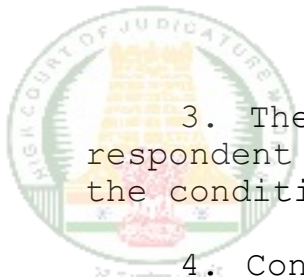
Prayer in CRL A(MD). 377/ 2022 :
