PRAYER : Criminal Original Petition is filed under Section 482 of Cr.P.C, to issue a direction to accept the surrender of the petitioner before the Special Court for SC/ST (Prevention of Atrocities) Act (i.e.,) First Additional District and Sessions Judge at Thanjavur, in connection with the Crime No.63 of 2023 on the file of the 2nd respondent police and to consider and dispose the bail application filed by the petitioner on the



petitioner is having previous cases. But, however, the above said decision has been clarified by the learned Additional Public Prosecutor and submitted that no previous case is pending against this petitioner.

5.Considering the facts and circumstances of the case, this Court is inclined to pass the following orders :-

- 1)The Petitioner shall appear before the learned I Additional District and Sessions Judge Special Court for SC/ST (Prevention of Atrocities) Act at Thanjavur, within a period of 15 days from the date of receipt of a copy of this order.
- 2)On such surrender along with notice served to the defacto complainant, the concerned Judge shall consider the bail application filed by the Petitioner and pass orders on merits on the same day of his surrender, after hearing the defacto complainant by complying with Section 15A(3) of the Act. The trial Court shall taken into consider the previous antecedents of the Petitioner while passing orders on merits.
